Proposed Revision

On February 2019, the principal office of JSPE has been moved from Akasaka 2chome, Minato Ward, Tokyo to Nihonbashi-honcho 4-chome Chuo Ward, Tokyo. In order to reflect this office move to the corporate public registration, article 2 of JSPE's articles of incorporation ("Teikan"), is proposed to be revised as follows.

Article 2

This corporation shall have its principal office in Minato Ward, Tokyo.

Article 2

This corporation shall have its principal office in Chuo Ward, Tokyo.

Resolution 4: FY2019 Action Proposal

Build Community and Connect with Public

One of the recent requirements to JSPE is transmission of engineering related information like complicated laws, engineering regulations, Japanese culture, PE license system, etc, with simple form and easy to understand for public. At the same time, through these transmissions, it is important to recognize the role of US PE license holder in Japan. Promotion of transmissions the Engineering Information to Public by Using JSPE Resources
