Resolution 1 : FY2019 Activity Report

During FY 2019, we have performed following activities under the four annual mission as (1) Promote Advocating Activities, (2) Continue Member Networking, (3) Improve member services, and (4) Streamline the Portfolio of Activities and the biennial policy of "Build Community and Connect with Public".

- For mission (1), outreach lectures to students at Mie University in April have been held and participate to panel discussion on "Development of Professional Engineers" by the Japan Society of Mechanical Engineers.
- For mission (1), Dispatch directors to NSPE annual meeting (PE Conference) in July, and got informed on NSPE Strategic Plan and partial changes to Bylaw.
- For mission (2), total 13 CPD seminars including Engineer's Salon have been held. Since the beginning of 2020, some seminars and PE license guidance have been postponed due to the influence of COVID-19, but PE license guidance are handled by e-mail, and some seminars are being distributed on the Web.
- In September, we held an off session at the Yokota Air Base as the first attempt, and also held a facility tour once each in Kansai and Kanto.
- For mission (3), we established senior membership system with the expectation of PE members satisfying their technological curiosity and contribute to the succession of technology to the next generation.
- In addition, we have started of JSPE Email Talking Point (Ogiri), which is a place for exchanging information among members, responded to increase in NSPE membership fee, introduced NSPE Webinar materials, organized past JSPE magazine information, and started of regular liaison meeting with JPEC.
- For mission (4), we held expanded board of directors meeting, including discussion about activity menu.

Resolution 2: Articles of Incorporation Revise

Proposed Revision

On March 2020, the principal office of JSPE has been moved from Nihonbashi-honcho 4-chome Chuo-ku, Tokyo to Kanda Misakicho 3-chome Chiyoda-ku, Tokyo.

In order to reflect this office move to the corporate public registration, article 2 of JSPE's articles of incorporation ("Teikan"), is proposed to be revised as follows.

(Current)

Article 2

This corporation shall have its principal office in Chuo-ku, Tokyo.

(Proposed revision)

Article 2

This corporation shall have its principal office in Chiyoda-ku, Tokyo.

Resolution 3: FY2020 Action Proposal

Build Community and Connect with Public -Continued

This year, we will continue the slogan "Building a network of engineers and society" from last year. Due to the influence of the new coronavirus, it is difficult to do JSPE activity in the same style as before. But we believe the catchphrase "Engineering helps us keep physical distance by means of social distance" and will develop the following activities using JSPE's past activities, websites, web conferencing tools, etc.

Promotion of transmissions the Engineering Information to Public by Using JSPE Resources

This year, we will supply the seminars listed in the next section, along with the web distribution of the seminars, so that members can view these videos and materials "anytime", "anywhere" and use them for self-improvement.

Continue Member Networking Services Through CPD Seminars

We will look for ways of holding CPD seminars at venues with keep physical distances for member's safety, health, and welfare. We also provide CPD seminars distributed on the web for members who have difficulty visiting to venue or who live in remote areas. Regarding the theme of the seminar, we will continue to implement environmental technologies that are cross-disciplinary for engineers and will expand ethics and risk management.

We will also use the web conferencing tools to conduct CPD seminars that focus on member exchange such as engineers' salons, and also create a place for exchanging information and exchanging information between PE holding members and members aiming for PE registration.

Improve the Membership Service Quality

We will Introduce online payment with PayPal system which makes it easy for members to pay tuition fees when participating in web CPD seminars. In addition, we will improve the member services by increasing the number of places for exchanging and exchanging information with members via email (Ogiri).

Streamline the JSPE Activity Portfolio (continued)

As mentioned in the above three activities, it is expected that face-to-face activities in the conventional style will become difficult in the future. While maintaining the physical distance between people, such as websites and web distribution, we will have a lively discussion and further study the activities of the association.

Furthermore, this year is the 20th anniversary of the establishment of JSPE, so we will hold commemorative booklets and hold special seminars.
