

## 7. 学歴評価以降

1. Colorado 州の PE ホームページにアクセスすると、以下のようなトップページが出てきますので新規アカウント登録に進みます。https://apps.colorado.gov/dora/licensing/Default.aspx



2. ここで問題が発生します。登録の過程で SSN 番号(米国の社会保障番号)が必要となり手続きを進められないのです。そこで問い合わせ先にメールしたところ、以下の PDF が送られ、これに記入すればアカウント発行いただけるとのことで、記載してメール添付で返送しました。







3. その後 2 週間音沙汰がないのでリマインダのメールを送り、3 週間後ようやく、仮のログイン ID とパスワードをメールで送ってもらいました。住所や誕生日は自分で登録するよう言われ、画面からやろうとしましたが、必須箇所が埋められないなど問題は続いて発生。そのたびにコロラド州の担当者とメールでやりとりして進めていきました。


4.アカウント登録が完了すると、以下の通り自分のアカウント画面が見られるようになります。PE 登録の手続きは黄色部分のリンクからスタートできます。学位や職務、犯罪歴などに関する一般的な内容の質問が尋ねられますので、回答します。




5. 5 分ほどで入力完了すると、以下の画面となり、100 \$ 請求されます。クレジットの情報などを入力し、支払います。約 1 週間後に、コロラド州から登録完了の連絡が届きます。アカウント画面から、PE 登録の進捗状況が確認できるようになります。




6. 次にコロラド州へ、自分の職務経験やレファレンス情報を送付する必要があります。元々は、コロラド州オリジナルのフォーマットで直に州の方に送ると思っていたのですが、コロラド州の担当者より、My NCEES から当該情報を登録するよう言われました。そのため My NCEES 画面の以下マーカ部分リンクから、必要な情報を登録していきます。レファレンスは全部で 5 名、うち 3 名は PE 保有者である必要があります。私の場合、以下の内訳でお願いしました。(1) 社内の非 PE 上司 (2) 社内の非 PE 教育統括 (3) 人事を通じて紹介してもらった社内の PE の方 (4) (3)の方のつながりで紹介いただいた PE の方 (5) JSPE で知り合った PE の方 (お世話になった皆さま、本当にありがとうございました。)




7. 上記リンクをクリックすると以下のような画面になります。



8. それぞれの登録が完了すると、以下の画面となります。1 番下の「Review」から内容の最終確認を行います。



9. Review が完了すると内容をコロラド州ボードに転送します。\$100 かかります。



10. 約一週間後、コロラド州からのメールで PE 登録完了の旨の連絡がきました。証明書が PDF で添付されていました。

登録まで長い道のりでしたが、社内外の多くの方に支援いただきここまでこぎつけることができました。お世話になった皆さま、本当にありがとうございました。引き続き気を引き締め、日々の業務に励んでまいります。
